Dear Mr. Meek,

I am sorry for not returning the forms earlier. The main reason is that we really do have dangerous situation that threatens to escalate into massacre against the Muslims in Sanjak. More than 20 000 of Serbian reservists with heavy military equipment have been stationed in Sanjak. Almost every day a citizens of Muslim nationality is being beaten or mistreated in some way. They all come to us to complain and they all ask for help and protection. The only thing that we can do is to take affidavits and statements from them, hoping that with the help of Interparliamentary Human Rights Network we can do something for people in Sanjak.

Therefore all my colleagues and I recommend 9 more parliamentarians from Muslim National Council Assembly who are also deputies in the Montenegrin Parliament, to be enlisted in the Interparliamentary Human Rights Network.

Please contact me if we missed anything in filling-in the forms, or in case we did not do it in a correct way.

I am looking forward to hear from you soon and I thank you for your cooperation.
