

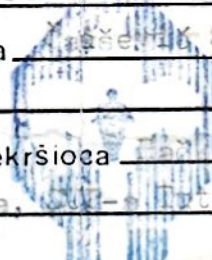

Opis slučaja:

Dana 7.01.1992. godine na ulici Pešterskoj ispred kafe penzionerske na oćigled više desetina građana koji su posmatrali ceo slučaj, bez ikakve prethodno uručene poziva nasilnički su nasrnuli gore pomenuti radnici SUP-Tutin, i uz odupiranje mogeg sine Čaušević Saita nasilno su ga oterali u SUP-u Tutin zajedno još sa drugim licem Kardović Hsanom, a posle toga bez ikakvog obaveštenja oterali u Garnizon u Rašku.

Ja sam kao bolesna majka ostala još sa jednim sinom koji je mentalno zaostao, a ja sam srćani teški bolesnik, tako da mi je sin koga su odveli jedini staratelj i hranilac mene i mojem drugom nesposobnom sinu, pa sam bila u Garnizon u Raški i oni su me odbili rekavši mi da moj sin nije htio da potpiše saglasnost da ide na front, i saopćtili su mi da istog dana vojna policija je tvoga sina sprovela u Vojno-istražni zatvor na Voćdovcu Ulica Ustanićka 15. u Beogradu. Najmanja kazna za ovo delo sleduje od jedne godine pa dalje da bude oćudjen pod vojni sud.

10.01.1992. godine ja sam lićno o svoje trošku bila u Beogradu u vojno istražni zatvor u Beogradu, rekli su mi da se moj sin nalazi u toj zatvoru a nisu mi dozvolili da ga vidim rekavši mi ćok nebuće sućenje i ćuće se iće nemoćemo ti dozvoliti posetu sa njim.

Protiv mogeg sina, koji je u vojno istražni zatvor u Beogradu vodi postupak samo zato što je odbio da ide na ratniće da ratuje bil protiv koga pa molim za zaštitu ljudski preva da se moj sin zaštititi.

AFIDAVIT/STATEMENT

Description of the case:

On the 7th of January 1992, in Pesterska street, in front of the pensioners' club, in witness of several tens of citisens who wre wat- ching the case withot any earlier showed warrant, the above mentio- ned two policemen have violently attaced my son Gausvic Sait , and have violently taken him to the Sip in Tutin , withot giving me any information they took him together with an-ether Kardovic Hasan to a garrison in Raska.

I am an ill mother, left alone with an other son who is mentally ill person , while I am a seriously ill patient with a heart defect , and my son who has been taken away to prison is the only sustainer or supporter of me and my other ill son. So I went to Raska garrison to ask for my son. I was told that uy son refused to sign an assent to go to war-, they refused to arrange avisit telling me that he had been already taken to a Military Investigating Prison , ustani- cka street 15 in Belgrade, by military police. He can at least be sentenced to one year inprisonment , and he can be further prosecu- ted by Military court.

On the 10th of January I went to Belgrade on my own account ,where Iwas told that my son is in prison and that a wisit could not be al- loweduntil he was taken to court, wich was to be next- the follow- ing week.

The procedure agaist my son is being taken just because he refused to go to war and to fight against anybody , therefore I am asking his protection and the protection of his human rights.
