In Sanjak's communes the securable situation is becoming worse from moment to moment. Beside the physical medio war, police torment and mistreat from Yugoslav Army are more frequent murders and kidnapps of Muslims. The existing authorities don't undertake any steps in providing Muslim's inhabitants safety and civil peace.

Unprotected Muslim's people are appealing to this Committee everyday and are asking for protection and are demanding from us to inform all relevant factors in all world to ask for help.

This Committee for protection of human rights has appealing more times to the proxycal institutions in Europe and the world but there were no significant practical help. And this time we inform you that Muslim's people in Priboj, Pljevlja, Prijepolje, Podgorica and other places in so-called Federal state of Yugoslavia is threatening the danger from total extermination.

We mention the case that happened 22 october 1992 in Sanjak's commune Priboj, when, about 7<sup>h</sup> o'clock in the village Mioča was stopped the bus from the side of so-called Yugoslav Army and from it they took away 28 Muslims and brought them away in unknown direction.

The same day from the village Sjeverin, local community Sjeverin the commune Priboj they also took away 7 Muslims, They were pupils and workers.

Belgrade daily newspaper 'Borba' in its number from 24 and 25 october of this year wrote that the part of seized Muslims from the village Mioča and Sastavak and took away in the direction to Višegrad and near Višegrad spa they made masaqre upon them. In 'Borba' stood that the masaqred Muslims are: Begović Ramiz (born 1933), Sajaterević Hajrudin (1955), Softić Mithad (1951), Softić Derviš (1953), Bajramović Mustafa (1948), Pecikoza Sejo (1962), Hodžić Medredin (1962), Čatović Sabahudin (1968), Čatović Ramahudin (1970), Hodžić Zafer (1956), Šebo Mehmed (1962), all from Priboj. And Mandal Alija (1954), Hodžić Nedo (1955) and his wife, Džinić Nusret (1956) and Džinić Esad (1968) all from local community Sjeverin.

Sanjak's committee for protection of human rights and freedom are alarming the Europe and world's publicity as well as authorized international institutions and are asking for pritting the worlds into deeds and undertake all that is in their power in order to help the Sanjak's people to keep their bare exgistance and biological survival.

We appeal on CSCE to send immediately their permanent watching mission. We also appeal on Tadeus Mazovjecki to come to Priboj as well as we eagerly want to come in Sanjak Cirus Vance, lord David Oven and Mr. Gerth Arens to see the real situation on the right place and by that way they world give the hope to the Muslims on thas territories that they have protection of them.



In den Gemeinden Sandžaks verschlechtert sich die Sicherheitssituation von Stunde zu Stunde. Neben dem Medien-Psycho Krieg, polizeilichen Torturen und Provokationen von Mitgliedern der Jugoslawieschen Armee, häufen sich die Mordfälle und Entführungen der Mohamedaner. Die aktuelle politische Macht unternimmt nichts gegenüber den Mohamedanischen Einwohnern, um ihnen eine Sicherheit und einen bürgerlichen Frieden zu versichern.

Die ungeschützten mohamedanischen Einwohner wenden sich jeden Tag an dieses Komitee und verlangen Schutz, und verlangen von uns das wir uns an alle relativen Faktoren in der Welt wenden und um Hilfe bitten.

Dieses Komitee für die Verhütung der menschlichen Rechte hat sich schon mehrmals an Institutionen in Europa und in der Welt gemeldet, aber bis jetzt gab es noch keine nennenswerte, praktische Hilfe.

Nocheinmals unterrichten wir Sie darüber, das der mohamedanischen Population in Priboj, Pljevlja, Prijepolje, Podgorica und in anderen Städten der sogenannten SRJ, die totale Ausrottungsgefahr droht.

Als Beispiel geben wir eine Situation die sich am 22. 10. 1992 in der Sandžakgemeinde Priboj abgewickelt hat. An diesem Tag um 7 Uhr morgens im Dorf Mioča wurde ein Bus aufgehalten von der sogenannten Serbischen Armee. Aus diesem Bus wurden 28 Mohamedaner herausgeführt und in unbekannte Richtung geführt.

Am selben Tag wurden aus dem Dorf Sastavak, Gemeinschaft Sjeverin, Gemeinde Priboj von den selben Angehörigen 7 Mohamedaner furtgeführt. Es waren Schüler und Arbeiter der mohamedanischen Nationalität.

Die Beogreder Tageszeitung "Borba" in der Ausgabe vom 24. und 25, Oktober dieses Jahres schrieb, das ein Teil der entführten Mohamedaner aus dem Dorf Mioča und Sastavak, nach richtung Višegrad geführt wurde.

Dieser Teil wurde dann beim Višegradischen Thermelbad brutal masakriert von Seiten der sogenannten Armee der Serbischen Republik Bosnien und Herzegovina. "Borba" schrieb das folgende Personen likvidiert wurden: Begović Ramiz (1933), Sajtarević Hajrudin (1955), Softić Mithad (1951), Softić Derviš (1953), Bajramović Mustafa (1948), Pecikoza Sejo (1962), Hodžić Medvedin (1962), Čatović Sabahudin (1968), Čatović Ramahudin (1970), Hodžić Zafer (1956), Šebo Mehmed (1962), alle aus Priboj. Mandal Alija (1954), Hodžić Nedžo (1955), und seine Frau, Džinić Esad (1968) alle aus der Gemeinschaft Sjeverin.

Das Komitee für die Verhütung der menschlichen Rechte und Freiheiten Sandžaks alarmiert die Europäische und die Allgemeinheit in der ganzen Welt als auch verantwortliche Internationale Institutionen, und bittet, da es Zeit ist, das man von Wörtern auf Taten wechselt. Und wir bitten das Sie alles unternehmen was in ihrer Macht ist und helfen Sie dem Mohamedanischen Volk in Sandžak, seine nackte Egsistenz zu schützen und sein biologisches Überleben zu versichern.


